Ms. Terkeurst,

Thank you for the time on the phone today. I will look forward to scheduling a date late March for me to present to the California Public Utilities Commission the source of what started the 2017 Northern California Fires. Please allow me about three weeks' notice for scheduling as I have a busy calendar. I will travel to Northern California to present my findings.

For your information,

I investigated the Tubbs, Atlas, Nuns, Cherokee, Sulphur, Redwood, Potter, Partrick, Adobe, Norrbom, Banger, Laport and Cascade fires. I would suggest personnel with the following background to attend if possible.

- 1. A relay protection Engineer with Ground Relay Protection and Ground fault analysis background
- 2. Transmission Design Engineering for wood pole Sub-Transmission lines
- 3. Distribution Pole Top Transformer Design Engineer
- 4. Transient Voltage Analysis Engineer
- 5. Management background running a utility Distribution yard following a major storm, lightning strike or system disturbance.
- 6. Strong Utilities Operations Back Ground.

Please be advised, although I was retained to perform the Investigation, and PRIMARILY BECAUSE OF SUCH A LARGE PUBLIC SAFETY ISSUE,, the firm agreed to let me present my finding directly to the CPUC to allow your discovery and investigations to focus on the issues that started the 2017 fires. I am doing this on my own without counsel as I did with

the CPUC for the 2007 Witch Creek fire that allowed the CPUC to obtain the discovery necessary from the utility for its own Internal investigation.

I will outline:

- 1. Why so many fires?
- 2. How come so many fires at the same time?
- 3. Root Cause (TWO MAJOR DESIGN PROBLEMS) of what started the fires as far as 300 miles apart from each other?
- 4. How did they get so large so fast?
- The remedies to take corrective action prior to the next fire season before another fire starts.

MEMORANDUM OF UNDERSTANDING BETWEEN SAN DIEGO CONSUMERS' ACTION NETWORK AND ED CLARK

This Memorandum of Understanding (MOU) is prepared and executed by San Diego Consumers' Action Network (SDCAN) and Ed Clark (CLARK) who will be working jointly in a California Public Utilities Commission proceeding, as set forth below.

CLARK will provide written Direct Testimony in CPUC Proceeding A.15-09-010 (SDG&E WEMA Proceeding) regarding SDG&E's (including Larry Davis, Esq., as well as other SDG&E and Sempra Executives) intentional concealment from CalFire, the CPUC and CPSD of origin and causation evidence related to the 2007 Witch Creek Fire (and prior fires, as relevant) and SDG&E's failure to preserve evidence related to such origin and causation. Such Direct Testimony may also include CLARK's conclusions and opinions regarding the cause and origin of the 2007 Witch Creek Fire. Testimony must be served upon parties on October 17th, so a final draft must be delivered to SDCAN no later than October 14th.

SDCAN anticipates that preparation of testimony and responses to any discovery requests will take no more than 20 hours of expert time. SDCAN will pay CLARK at a rate of \$350 per hour and will establish a cap of \$7000. At the time that the \$7,000 contract cap is reached, CLARK will notify SDCAN, at which time SDCAN continue to at the rate of \$350 per hour for any additional authorized work done for SDCAN in this case.

SDCAN will prepare an outline of CLARK's draft testimony. After delivery of this draft and agreement on the nature of the testimony, SDCAN will tender a retainer of \$2500. Upon completion of the testimony, SDCAN will tender an additional payment of \$2500. Final payment of any remaining monies will be provided upon the submission of the case to the CPUC. None of the services provided by CLARK will be contingent upon the case outcome.

Because SDCAN will have other consultants and internal staff working on this case (along with internal staff), we request that CLARK attempt to defer to SDCAN for time-consuming detail work that can be delegated. We wish to use CLARK's resources and expertise as efficiently as possible and will provide as much support as possible so as to best use CLARK's time.

Both CLARK and SDCAN retain separate rights to use CLARK's testimony for any purpose.

Finally, both parties understand and expect that CLARK will offer CLARK's best professional opinion on the substantive matters in this case. SDCAN has no predisposed agendas or requirements as to the recommendations tendered by CLARK in this case. SDCAN's recommended revisions to CLARK's testimony will be limited to ensuring that the testimony meets the standards expected of the regulatory body and that they are within the scope of the case established by the Commission. Ultimately, CLARK will approve any modifications to CLARK's testimony. This will be CLARK's

work product and SDCAN's involvement will be focused on preparing it for litigation purposes only.

Accordingly, CLARK acknowledges that he has not agreed to refrain from disclosing any of his findings, opinions or documents and that none of his findings, opinions and documents are protected by any attorney-client, attorney work-product, mediation confidentiality or other confidentiality provision, nor will they be in the future.

These commitments encompass the entirety of the actions to which the signing parties have agreed. This memorandum can be revised at any time, pursuant to agreement by the undersigned parties.
